

DEED OF APPOINTMENT (ABSOLUTE)

Introduction

You can use this deed to appoint that the plan proceeds in the trust are no longer to be held for the named beneficiary. Instead, they are to be held for specific beneficiaries within the wider group of discretionary beneficiaries, as determined by the trustees after a claim has been paid. The plan proceeds can then be distributed to the chosen discretionary beneficiaries.
